
Indiana Family Health Council

Indiana Family Health Council (IFHC) is a nonprofit organization that has been a Title X grant recipient since the 1970s. In 2022, IFHC began providing Title X services in eastern Illinois. In Illinois, IFHC delivers services to approximately 8,000 clients annually through direct service sites, a mobile health unit, and telehealth.¹

Overview of Services Offered

As a Title X recipient, IFHC provides a broad range of FP services including pregnancy prevention and birth spacing, pregnancy testing and counseling, assistance to achieve pregnancy, basic infertility services, sexually transmitted infection (STI) services, and other preconception health services. The services are voluntary, confidential, and provided regardless of ability to pay.³ The infographic below is an Overview of Services Offered within the IFHC network. The data shown below are not specific to any particular site but rather are representative of the broader grantee network. Equity in Practice



IFHC recently added questions to its intake questionnaire to assess clients for nonmedical issues affecting their health, such as access to nutritious foods, safe housing, education, and employment opportunities. By assessing clients for these social factors, providers can make better-informed decisions about treatment and care and refer clients to additional services.

Innovations in Practice



To better meet the needs of rural communities in eastern Illinois, IFHC is operating a mobile health unit to provide FP services for seven counties that have not had access to Title X services for more than a decade. The mobile unit is a full-service, Americans with Disabilities Act—compliant vehicle and can provide the same services as those offered in a traditional FP clinic.

Did You Know?



IFHC is creating a social media campaign about the availability of the mobile health unit and its services. The outreach will focus on human service agencies and businesses to help coordinate services for client populations most in need. IFHC is working with the Mobile Healthcare Association, a membership organization that helps health care entities successfully offer mobile health programs, to learn about and implement effective outreach strategies.



STI and HIV/AIDS education, counseling, and testing are integrated into all routine care at IFHC service sites in Illinois. STI/HIV testing is considered opt-out testing, offered to all clients at their initial and annual visits, STI visits, and as indicated or desired by clients. This approach increases the number of clients tested annually and ensures clients get timely treatment.



IFHC has established a strong network of partners to increase access to FP services, including partners in the business sector. For example, IFHC partners with the manufacturers of a new brand of emergency contraception to donate doses to clinics in its network at no cost. IFHC also partners with Direct Relief, a nonprofit humanitarian organization that provides long-acting reversible contraception at no cost for uninsured patients. These partnerships increase access to contraception for clients in need without added cost burdens to the grantee or client.
