
Bridgercare dba Montana Family Planning (MFP)

Bridgercare, dba Montana Family Planning (MFP), is a nonprofit organization that has been delivering Title X services since the 1970s. Bridgercare recently took over the state's Title X grant from the Montana Department of Public Health and Human Services. MFP delivers services to approximately 18,000 clients per year.¹

- Number of family planning (FP) encounters 18,038

Overview of Services Offered

As a Title X recipient, MFP provides a broad range of FP services including pregnancy prevention and birth spacing, pregnancy testing and counseling, assistance to achieve pregnancy, basic infertility services, sexually transmitted infection (STI) services, and other preconception health services. The services are voluntary, confidential, and provided regardless of ability to pay.³ The infographic below is an Overview of Services Offered within the MFP network. The data shown below are not specific to any particular site but rather are representative of the broader grantee network. Equity in Practice



MFP has a standing reproductive justice committee that works to identify ways the organization can be inclusive and equitable for clients who identify as Black, Indigenous, and people of color (BIPOC), and for clients who have limited English proficiency. The reproductive justice committee also receives support and leadership from a BIPOC advisory committee, a group made up of community members who provide feedback and lived experience perspectives to MFP's services, policies, and culture. MFP also requires all staff to complete a six-hour training on racial disparities in health care and how to engage in anti-racism work.

Innovations in Practice



Most Indigenous people in Montana live in tribal communities far from large population centers that have widely available FP services. To make FP services more accessible, MFP hired a tribal liaison upon grant award in 2022 to build and strengthen relationships with the state's tribal communities and develop and support a tribal community advisory committee. The committee will assist MFP in better understanding the need for family planning in tribal communities, developing appropriate service settings responsive to these needs, and reviewing the potential for expanding services through telehealth and trusted providers capable of delivering culturally responsive services.

Did You Know?



Some service sites in the MFP network are working with detention centers to offer health education and STI testing in prerelease centers. Recognizing how difficult it can be for recently released individuals to access health care, the grantee offers free sexual/reproductive health services at its clinic in Bozeman for formerly incarcerated individuals for up to three months following their release.



MFP staff understand how difficult it can be for individuals living in rural, frontier, or tribal communities to access family planning services. Providers in public health departments throughout the state are trained to screen for the need and desire for family planning services when clients are accessing other public programs (for example, the Special Supplemental Nutrition Program for Women, Infants, and Children) so several client needs can be met in one visit.



In addition to the efforts mentioned above, to expand access to family planning services for rural, frontier, and tribal communities, MFP is forming new partnerships with Urban Indian Health Clinics, tribal health departments, and federally qualified health centers located in rural areas of the state.
