City of Carson City

This grantee dba Carson City Health and Human Services (CCHHS) is a city agency that provides family planning services to two counties in the northwest area of Nevada, Carson City and Douglas County. CCHHS has received funding through Title X for over 20 years since the early 2000s. It delivers services to approximately 2,000 clients through county health departments.1

Overview of Services Offered

As a Title X recipient, CCHHS provides a broad range of FP services including pregnancy prevention and birth spacing, pregnancy testing and counseling, assistance to achieve pregnancy, basic infertility services, sexually transmitted infection (STI) services, and other preconception health services. The services are voluntary, confidential, and provided regardless of ability to pay.3 The infographic below is an Overview of Services Offered within the CCHHS network. The data shown below are not specific to any particular site but rather are representative of the broader grantee network. Equity in Practice



As a public health department accredited by the Public Health Accreditation Board, CCHHS has conducted a community health assessment to help create a community health improvement plan. The assessment revealed that access is a large barrier to care for the grantee's clients, so using the same third-party contractor used to conduct the community health assessment, CCHHS decided to conduct "secret shopper" calls to different providers around the region, including its federally qualified health centers (FQHCs) and other private, primary care providers. The callers would ask different questions about how long it would take to get an appointment and be seen, and for most it would take about three weeks. As a result of the calls and the long wait times, many local providers moved to same-day or next-day scheduling to help reduce no-show rates and improve access to services for their clients. CCHHS had same-day/next-day appointment practices for several years after a partnership with RHNTC for technical assistance on best practices for scheduling.

Innovations in Practice



To increase access and awareness for youth in the community, the adolescent health coordinator and the tobacco cessation program coordinator partner to bring high school students into the health department to conduct their health class. Students can learn about the services available to them and avoid the anxiety and stigma associated with walking through the clinic doors. CCHHS also surveyed youth to assess clinic environment and, based on the youth's responses, made changes to make the lobby more friendly, accessible, and comfortable.

Did You Know?



Instead of using a one-size-fits all strategy, CCHHS has relied on a mix of approaches to community outreach to raise awareness and improve access for different populations. For example, the grantee advertised on Latinx radio stations, hired community health workers who conducted presentations throughout Carson City and Douglas County for a year, and distributed flyers to many prominent service agencies in their community. CCHHS also presents at community outreach events and ensures agency staff can speak about services provided at the clinics.



CCHHS has used data to improve service quality in several ways. It uses technical assistance trainings offered by the Reproductive Health National Training Center and external consultants to strengthen its data collection processes. CCHHS works with contractors and the Board of Health to regularly assess community needs to develop a community health improvement plan. CCHHS also conducts patient satisfaction surveys and uses them to have intentional discussions about ways to strengthen service delivery.



CCHHS has built a wide variety of strong relationships with other departments in its agency and organizations in the region to improve availability and access to care. CCHHS maintains partnerships and referral services through Northern Nevada HOPES clinic in Washoe County, which provides HIV care throughout Northern Nevada. CCHHS frequently partners with the University of Nevada in Reno to collect data, and with one women's health organization that pays for ultrasounds for uninsured women who have a mass in their breast, and for genetic testing and counseling for women.
