


Idaho Department of Health and Welfare

Idaho Department of Health and Welfare (DHW) has been a statewide Title X grant recipient since the 1970s. DHW delivers services to approximately 6,000 clients a year through subrecipients including county health departments and federally qualified health centers (FQHCs).¹

Stats at a Glance²

- ▶ Number of family planning (FP) encounters – 6,593
- ▶ FP users with incomes below 100% Federal Poverty Level (FPL) – 3,089 (47%); all FP users with incomes below 250% of FPL – 5,412 (82%)
- ▶ Number of tests performed for gonorrhea – 2,195, syphilis – 606, and HIV – 783
- ▶ Number of female users who received a chlamydia test – 1,714 or a Pap test – 1,174

Overview of Services Offered

As a Title X recipient, Idaho DHW provides a broad range of FP services including pregnancy prevention and birth spacing, pregnancy testing and counseling, assistance to achieve pregnancy, basic infertility services, sexually transmitted infection (STI) services, and other preconception health services. The services are voluntary, confidential, and provided regardless of ability to pay.³ The infographic below is an Overview of Services Offered within the Idaho DHW network. The data shown below are not specific to any particular site but rather are representative of the broader grantee network. Innovations in Practice



Idaho DHW and its subrecipients are finding creative strategies to increase awareness about Title X services and clinic locations across the state. At the grantee level, DHW is promoting the project through dating apps, with messaging geared toward people ages 18–24, who have the highest rates of unplanned pregnancy in the state. DHW is also looking into ways to promote the program to younger people who may face cost or policy barriers to preventive services. One way it accomplishes this is by doing promotion at postsecondary and vocational schools. Idaho DHW also developed a poster in English and Spanish that can be used by subrecipients to promote the high quality, affordable services available through Title X. The poster contains a QR code that links to the clinic locator web page. Subrecipients are also strategizing ways to increase awareness of the program. One agency in the network has partnered with a popular local pharmacy to provide information about the Title X clinics and services provided by the pharmacy.

Did You Know?



Coming out of the COVID-19 pandemic, Idaho DHW saw a need to increase screening for mental health, substance abuse, and social determinants of health. The grantee asked its network of Title X providers to increase screening, however, this effort presented a challenge for clinic staff who were already working at capacity. To support them, subrecipients brought on care coordinators that serve sites across the network to ensure that clients who were identified as needing services based on screening were getting the referrals and connections they needed.



Idaho DHW is working with subrecipient agencies to integrate culturally appropriate care into its operations, with the goal of increasing quality of care for all its clients. Subrecipients developed disparity impact statements that include activities to increase staff's cultural humility. Additionally, clinics are hiring staff who represent the communities they serve and making sure translation services are available so they can successfully communicate with anyone who comes in for services. The grantee also helps improve quality of care by offering training in implicit bias for providers.



Idaho DHW collaborates closely with other state programs such as Temporary Assistance for Needy Families (TANF) to increase community knowledge of the Title X program. As part of this collaboration, a free program called Families Talking Together encourages parents and guardians to be involved in youth's sexual health by teaching them how to talk to their children about this topic. Through the collaboration with TANF, DHW shares information about Title X services and clinics with parents and guardians.
