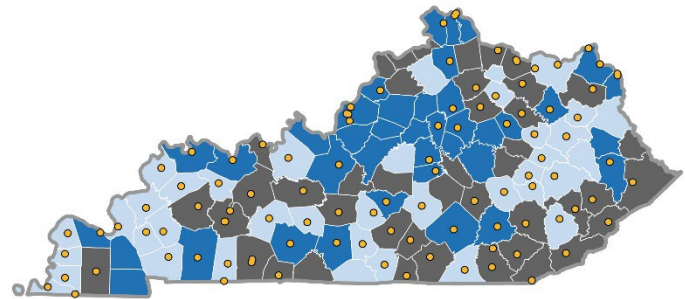


Kentucky Cabinet for Health and Family Services

The Kentucky Cabinet for Health and Family Services (Kentucky Family Planning) is a state-level agency that has been a Title X grant recipient since the 1970s. Kentucky Family Planning oversees subrecipients and service sites who operate city or county health departments, federally qualified health centers (FQHCs), and FQHC look-alikes.¹

Stats at a Glance²

- ▶ Number of family planning (FP) encounters – 46,524
- ▶ FP users with incomes below 100% Federal Poverty Level (FPL) – 16,772 (56%); all FP users with incomes below 250% of FPL – 21,544 (72%)
- ▶ Number of tests performed for gonorrhea – 10,321, syphilis – 2,236, and HIV – 4,057
- ▶ Number of female users who received a chlamydia test – 9,046 or a Pap test – 4,906

Overview of Services Offered

As a Title X recipient, Kentucky Family Planning provides a broad range of FP services including pregnancy prevention and birth spacing, pregnancy testing and counseling, assistance to achieve pregnancy, basic infertility services, sexually transmitted infection (STI) services, and other preconception health services. The services are voluntary, confidential, and provided regardless of ability to pay.³ The infographic below is an Overview of Services Offered within the Kentucky Family Planning network. The data shown below are not specific to any particular site but rather are representative of the broader grantee network. Innovations in Practice



Kentucky Family Planning uses its local advisory groups to get input from people who are broadly representative of communities served by the Title X program across the state. Input from communities covers the development, implementation, and evaluation of services and education. For example, one community advisory group shared how clients would benefit from convenient access to free condoms in exam rooms, and the service site promptly implemented this suggestion. The service site reported that the availability of free condoms has created opportunities for staff to initiate conversations with clients about contraceptives and Title X services more broadly. In addition, Kentucky Family Planning collaborated with a statewide advisory group to develop tools to inform and educate service providers on how to connect with and serve adolescents. One tool is an adolescent-friendly survey that will gather information to assess the types of services adolescents need, how they prefer to receive services, and their current understanding of contraceptive and reproductive health.

Did You Know?



Kentucky Family Planning continuously finds opportunities to use feedback from subrecipients and service sites to improve service delivery. For example, based on subrecipient feedback on the availability of data, the grantee revamped its state website to display an interactive map that includes data on family planning, such as teen birth rates, social vulnerability index, and STI rates for each county. Each subrecipient may use the interactive map to better understand its community. The interactive map also fosters cross-site collaboration and problem solving. Subrecipients can visualize how their community compares to surrounding communities, the state, and the country.



Kentucky Family Planning partnered with two entities—the Kentucky Nursing Office and the Sexually Transmitted Disease Prevention and Control Program—within the Infectious Disease branch to assist with the launch of the Expanded Role Registered Nurses (ERRN). This role was created to improve the quality of STI testing, address staff capacity issues, and strengthen overall access to FP services, even when a physician is not available. Through this partnership, registered nurses are eligible to receive STI ERRN training that follows Centers for Disease Control guidelines.



Kentucky Family Planning has invested time to strengthen its relationships and communication with subrecipients and service sites by holding monthly "lunch and learns" that cover topics ranging from service delivery to data collection. For example, one lunch and learn focused on strengthening community engagement to effectively and equitably gather client input to inform program improvements. During the meeting, subrecipients and service sites shared barriers and successes in community engagement and worked together to problem-solve their concerns. In addition to creating an opportunity for the grantee to strengthen Kentucky Family Planning's relationship with each subrecipient and service site, the collaborative structure of the lunch and learns creates an opportunity for subrecipients and service sites to strengthen their relationships with one another in small groups.
